

Information on the processing of personal data ex artt. 13-14 EU Reg. 2016/679

 - Data disclosure:: Your personal data will not be disclosed in any way.

Data retention:: Please note that, in compliance with the principles of lawfulness, purpose limitation and data minimization, pursuant to art. 5 of the GDPR, the retention period of your personal data is::

- Established for a period of time not exceeding the achievement of the purposes for which they are collected and processed for the execution and completion of the contractual purposes;
- Established for a period of time not exceeding the achievement of the purposes for which they are collected and processed and in compliance with the mandatory time limits prescribed by law.

EU Reg. 2016/679: Artt. 15, 16, 17, 18, 19, 20, 21, 22 – Right of data subject

1. Data Subject has the right to obtain confirmation of the existence or not of personal data concerning him, even if not yet registered, and their communication in an intelligible form.

2. Data Subject has the right to obtain the indication:

- a. of the origin of personal data;
- b. of the purposes and methods of treatment;
- c. of the logic applied in case of treatment carried out with the aid of electronic instruments;
- d. of the identifying details of the holder, of the responsible and of the designated representative according to article 5, paragraph 2;
- e. of the subjects or the categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the territory of the State, managers or agents.

3. Data Subject has the right to obtain:

- c. the attestation that the operations referred to in letters a) and b) have been brought to the attention, also with regard to their content, of those to whom the data have been communicated or disclosed, except in the case in which this fulfillment proves impossible or involves a use of means manifestly disproportionate to the protected right; la portabilità dei dati
- d. Data portability.

4. Data subject has the right to object, in whole or in part:

- a. for legitimate reasons, the processing of personal data concerning him, even if pertinent to the purpose of the collection;
- b. To the processing of personal data concerning him for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication..
