EU Reg. 2016/679: Artt. 15, 16, 17, 18, 19, 20, 21, 22 - Right of data subject

- 1. Data Subject has the right to obtain confirmation of the existence or not of personal data concerning him, even if not yet registered, and their communication in an intelligible form.
- 2. Data Subject has the right to obtain the indication:
 - a. of the origin of personal data;
 - b. of the purposes and methods of treatment;
 - c. of the logic applied in case of treatment carried out with the aid of electronic instruments;
 - d. of the identifying details of the holder, of the responsible and of the designated representative according to article 5, paragraph 2;
 - e. of the subjects or the categories of subjects to whom the personal data may be communicated or who can learn about them as appointed representative in the territory of the State, managers or agents.
- 3. Data Subject has the right to obtain:
 - a. updating, rectification or, when interested, integration of data;
 - b. the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed;
 - c. the attestation that the operations referred to in letters a) and b) have been brought to the attention, also with regard to their content, of those to whom the data have been communicated or disclosed, except in the case in which this fulfillment proves impossible o involves a use of means manifestly disproportionate to the protected right;la portabilità dei dati

- 4. Data subject has the right to object, in whole or in part:
 - a. for legitimate reasons, the processing of personal data concerning him, even if pertinent to the purpose of the collection:
 - b. To the processing of personal data concerning him for the purpose of sending advertising or direct sales material or for carrying out market research or commercial communication..
